Any individual or legal entity making a purchase; (hereinafter referred to as "the customer").

Regulations and conditions for booking and payment for group visits

For group visits booked via the group service, payment is made:

- Before the visit by bank cheque (payable to SCI du Château de Villandry) or bank transfer (Crédit Agricole Touraine Poitou - IBAN: FR76 1940 6370 7267 1899 0943 556 - BIC: AGRIFRPP894) for the full provision of service (prepayment of proforma invoice or quote; no reimbursement will be granted in the event of a change in personnel or cancellation of the visit by the customer)
- Using a returns coupon/voucher/administrative coupon (a copy must be sent by the customer prior to the group visit; the original document must be presented on the day of the visit, otherwise payment on site is required).
- Payment on site on the day of your visit at the counters of the Château de Villandry can be made in a single transaction by bank card (Visa/Mastercard, Carte Bleue, excluding American Express), by bank cheque (made payable to SCI du Château de Villandry), or in cash.

Payment terms applied to group invoices

The request for a quote (or pro forma invoice) is free of charge. The document remains valid for the current tourist season (calendar year).

Payment deadline: upon receipt of the invoice, unless previously agreed between the parties.

In the event of late payment, statutory fixed compensation for recovery costs: €40.00

- up to 30 days from the date of the visit, 60% of the value due under the "guided tour" or "workshop" or "audio guide rental" package will be invoiced to the customer.

- up to 15 days from the date of the visit, 80% of the value due under the "guided tour" or "workshop" or "audio guide rental" package will be invoiced to the customer.

- up to 5 days from the date of the visit, 100% of the value due under the "guided tour" or "workshop" or "audio guide rental" package will be invoiced to the customer.
